## Employers Liability - Limit £10,000,000 any one event

Inclusive of legal costs and expenses incurred in defending a claim with insurers' consent.

**Cover:** Accidental bodily injury by violent, external and visible means whilst engaging in cricket umpiring or scoring activities, including commuting thereto and/or therefrom.
